CERTIFICATE OF WATER RIGHT

This Is to Certify, That RAYMOND M. & V. FERNE DUNCAN

of Ironside, State of Oregon, 97908, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Fork Willow Creek

a tributary of Willow Creek for the purpose of supplemental irrigation of 104.7 acres

under Permit No. 36682 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 16, 1972 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.60 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 28, T. 14 S., R. 39 E., W. M., 2670 feet North and 980 feet East from the SW Corner, Section 28

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that although declared herein to be for supplemental irrigation the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

 2.1 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
 16.8 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
 37.8 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
 20.0 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
 Section 28
 1.2 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
 17.5 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
