KNOW ALL MEN BY THESE PRESENTS, that the State Reclamation Commission of the State of Oregon, acting for and on behalf of said state, hereby

RELINQUISHES AND RECONVEYS TO THE UNITED STATES OF AMERICA certain lands mentioned in contracts entered into January 12, 1904, (Oregon Segregation List No. 13) and February 10, 1921, (Oregon Segregation List No. 37) between the Secretary of the Interior, acting for and on behalf of the United States, and the State Land Board and Desert Land Board, predecessors of the State Reclamation Commission, acting for and on behalf of the State of Oregon, providing for the reclamation and irrigation of certain lands under the provisions of Section 4 of the Act of Congress approved August 18, 1894 (Carey Act) and acts of Congress supplemental thereto, and amendatory thereof, said lands hereby relinquished and reconveyed being located in Deschutes County, Oregon and described as follows, to-wit:

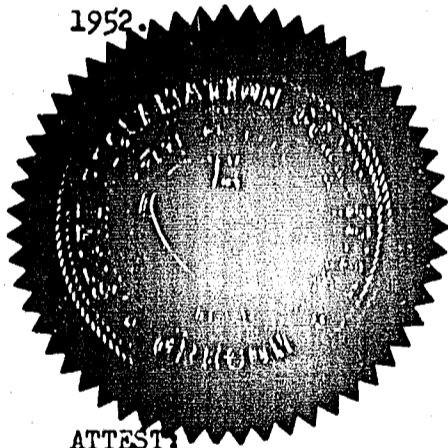
